# President's Message

### Hello neighbors-

We held our first Quarterly meeting for the 2017 year on January 23 at the JCC. Our annual budget was presented and was unanimously approved. This was the meeting that all homeowners get to participate in our homeowner governing process. Many thanks to our residents that attended and entered the discussion about the running of our Association.

Please remember that your Block Director is your connection to the Board of Directors and each of you need to meet your Director in person. Your Director's name and contact information is on the last page of any Gazette. About a year ago, your Director visited you and left a Consent form to approve our Proposed Deed Restrictions. We are still trying to get the 51% needed to register these Restrictions at the courthouse. Please contact your Director if you need an updated copy of this Consent form or are new to the neighborhood. We have been trying as an Association to approve these Restrictions since early 2014. Please help upgrade our rules to current standards with your approval.

We have three vacancies on our Board of Directors. They are the 5500 block of Wigton, 5400 block of Cheena, and Atwell and S. Braeswood. If you are interested, please contact any officer of the association.

You may have noticed in adjoining neighborhoods that there are stickers on storm drains furnished by the City of Houston called Clean Water/ Clear Choice. These stickers remind us that our storm drains are designed to carry only storm water from our streets and nothing else. Trash, grass clippings and chemicals should not be sent down these drains. Remember everything put into these drains ultimately end up in Galveston Bay and the Gulf of Mexico. Sea life mistakes this debris for food and often die when they digest it. Please be a good neighbor to our environment.

Our Board voted to remove mosquito spraying from the services provided by our Association. This spraying is controversial and Meyerland Association does not spray either. The spray kills pollinators such as bees, butterflies and bugs beneficial to our food supply. There are many exterminators that perform this service, the choice is yours.



## Friends in Marilyn Estates,

Mayor Turner and I recently hosted a press conference, along with new Police Chief Art Acevedo and Harris County Sheriff Ed Gonzalez, to announce a new 4-year plan to combat human trafficking in Houston.

The program seeks to not only highlight this critical issue in the weeks leading up to the Super Bowl, but also to continue aggressive enforcement against both sex and labor trafficking after the big game is over.

Objectives include, among others:

• Providing training for City workers as well as hotel and taxi industry employees on how to spot and respond to trafficking situations

• Ensuring the public has access to information on how to make safe choices when patronizing businesses frequently used as fronts for trafficking, such as massage parlors and nail salons

• Publishing online tool kits to increase community awareness and engagement.

In addition, going forward, law enforcement agencies have pledged to distribute photos to media outlets of those found paying for prostitution, which can often involve a trafficking victim.



# Yards of the Quarter

The YOTQ will be judged four times a year, mid-January, mid-April, mid-July, mid-October. In addition there will be a Winter Holiday Front Yard Decoration contest which be judged in mid-December.

The criterion considered for YOTQ will be:

- Overall appearance of the front of your home.
- Excellent maintenance of total front yard i.e. grass mowed and edged.
- · Bushes and trees trimmed
- Ornaments or decorations tastefully displayed
- Except for pick up day, no garbage, recycle container or yard bags at curbside.
- Innovation and creativity will be taken into consideration.
- To qualify for YOTQ, homes must have their address clearly visible from the street (this is a city ordinance).

For the YOTQ, we are selecting a maximum of one home per block. In order to provide opportunities to recognize more homes, the YOTQ will only be awarded to any property only one time during the calendar year. In rare instances, if no home qualifies, there will be no home recognized on the street. Four mystery judges will be cruising through our subdivision five times a year. They will not be evaluating their own block.

# Marilyn Estates Association Minutes: Quarterly Meeting

Tuesday January 23, 2017 Jewish Community Center

President Carter Hixon called the meeting to order at 7:04 p.m. and Nancy Hixon, filling in for Parliamentarian Lynn Busch, certified that there was a quorum.

On motion made and seconded, the minutes of the October 25, 2016 meeting were unanimously approved and accepted as submitted.

President Carter spoke for a few moments about the six inches of rain that fell on January 18. To his knowledge, no houses received flood waters. One resident at the meeting said that they got water in their home on Valkeith.

The Board met last week and discussed the mosquito spraying that we have had

contracted in our sub-division. It was decided to discontinue this service. Each household can make their own decision as to whether they want to spray or not. There were only seven cases of Zika virus reported in Harris County during 2016 and all of those cases were from people who had visited South America. The virus carrying mosquito is active at dusk and at dawn, while the spraying would take place at night, making this service ineffective. We were told of two inexpensive ways to keep the mosquitos away, spreading cedar mulch on your flower beds and making sure there is no standing water near your home.

There have been three Block Director openings for some time. If anyone would like to volunteer for the 5400 block of Cheena, the 5500 block of Wigton or the seven or eight houses near the intersection of Atwell and S. Braeswood, please contact Carter.

The yearly dues statements are going to be sent via email to all those residences that have an email address on file. Otherwise, a hard copy will be mailed. The first round will go out by February 1. A second notice will be mailed to those who have not paid their dues by Feb 21. A \$25 late fee will be charged beginning April 1. Another late charge will be assessed in June. If you've noticed stickers on the storm drain covers that says Clean Water/Clear Choice, the City of Houston has started a program called SWIM. This program stresses these points: Don't over fertilize your yard, don't fertilize if it is going to rain, leave grass clippings on the yard (this is great for your grass), use lawn chemicals only when necessary and don't put anything down the storm drain. Remember, anything that goes into the street and down the drains end up in Galveston Bay and becomes potential food and poison for sea life.

Our Treasurer, Robert Gehring, presented the proposed budget. There was a question about the increased legal fees. Carter explained how legal action is required when homeowners abandon houses or don't take care of their properties and numerous warnings has been given. There are also homeowners who have violated deed restrictions that require legal action. On motion made and seconded, the budget was unanimously approved and accepted as submitted.

Maintenance and Beautification Report

Unfortunately, the flooding we just had wiped out the beautiful flowers that were planted in the esplanades. They were not warrantied because it was storm damage. Linda will meet with the contractors to plan the spring planting. There was an increase in the budget for her to have a double planting twice a year to give our neighborhood the Wow! factor. There was some discussion about a new group that has formed to develop hiking and biking trails from the Braes Bayou trails down Chimney Rock to the Willow Waterhole. More discussion is planned.


On motion made, seconded and unanimously carried, the meeting was adjourned at 8:14 p.m.
