Security Report

With many neighbors having to vacate their homes temporarily due to the flood and rebuilding for the next several weeks and months, we encourage notifying Pct. 5 and having special watch on your home. We also need to continue watching for any suspicious people and vehicles in our area and calling Constable Precinct 5 dispatch at 281-463-6666 and providing the location and description as soon as possible. Law enforcement recommends installing cameras to record activity to be used as evidence and leading to arrest and conviction, in addition to having a home alarm system.

You are also encouraged to utilize the Constable website at constablepct5.com to get neighborhood news and homeowners can sign up for crime alerts and select Marilyn Estates contract. You can also call Constable Precinct 5 dispatch to request vacation watch in addition to a special watch mentioned above on your home and a deputy will stop by to get your information for more immediate watch or you can do this online if you can give at least 5 days notice before your trip from either using the link in the security section of our website: http://www.marilynestates.com/ or http://www.constablepct5.com/.

Here are key security tips from Pct. 5 to keep in mind each day and night:

Keeping Your Home Safe

Residents are asked to do their part in reducing the number of offenses by making sure their doors and windows are locked at all times. Leave lights on outside, and do not leave valuable items in plain sight. If you have bushes near the house, keep them at a height where it is not easy for a potential burglar to hide behind them.

Keeping Your Vehicle Safe

Residents are asked to do their part in reducing the number of offenses by locking their cars at all times, even if you're "just running inside for a second." If someone is watching, the moment you walk inside they could be in your car and gone before you get back. Please remove all valuable items from your vehicle, as well.

Be sure to program Constable Precinct 5 dispatch phone number 281-463-6666 into your cell phone and notify your alarm company to have this number entered into their system, preferably as first responder.

Thanks for all of your help and awareness in fighting crime and making progress from the flood recovery for our neighborhood.

Discover the Willow Waterhole

Did you know that we have a beautiful park and conservancy right "in our own backyard"? The Willow Waterhole is just that, a 291-acre park located in Southwest Houston. It is part of the Willow Waterhole Greenspace Conservancy, whose mission as stated on the website, www.willowwaterhole.org, is "to mobilize individuals, neighborhoods, government agencies, businesses and foundations to support the creation of the Willow Waterhole Conservation Reserve."

Many people may be familiar with Willow Waterhole as part of flood control efforts. The Willow Waterhole Greenway Project is part of the Harris County Flood Control District and U.S. Army Corps of Engineers' Project Brays. The project combines flood control, detention lakes, and the park, while promoting conservation and community use and involvement. (You can also visit project www.projectbrays.org for the latest information on this major flood control effort and to find out where work is underway now.)

According to the website, besides adding a great park to our city, Willow Waterhole has been designated a top birdwatching site, is used by the community and schools for a variety of events, and is an entertainment venue, including the site of the annual Willow Waterhole Music Fest. Walking trails, gazebos, and ponds make the area a welcoming and peaceful place to visit.

Marilyn Estates residents have a special connection to Willow Waterhole. The Schwartz Gazebo at the Willow Waterhole Greenway is named in honor of the late Bob Schwartz, who lived in Marilyn Estates and was one of the most dedicated and hardworking volunteers for Marilyn Estates and the community. What a great way to honor Bob.

The Willow Waterhole is located near the intersection of South Post Oak Road and South Main.

Thanks to Exiting MEA President Carter Hixon

Heading up a volunteer neighborhood organization such as the Marilyn Estates Association is not an easy job, but Carter Hixon handled it with style and grace for three years.

Previous to his service as MEA President, he served several years as Vice President and concurrently worked with the late Bob Schwartz on the Deed Restriction Enforcement Committee. Programming at the Levitt Pavilion will be unique to Houston, reflecting the diversity of the neighboring communities and the entire city. In addition to a rich array of music genres, multiple cultural performances will also be part of each annual concert series with the Levitt Pavilion also serving as a stage for cultural exchange.
