Security Committee

We all need to be the eyes and ears of our neighborhood and pay close attention. Report any suspicious people and vehicles by calling Constable Precinct 5 dispatch at 281-463-6666. Provide the location, description. and license plate number if you can see it and write it down.

Law enforcement recommends that each homeowner install a home alarm system along with security cameras to record activity. This can be used as evidence and lead to an arrest and conviction.

It is also encouraged that homeowners call Constable Precinct 5 dispatch to request vacation watch on your home; a deputy will stop by to get your information before your trip. For example, the Silver Watch program for senior citizens will check on their safety and wellness, and Special Watch programs are designed for special circumstances such as stalking or illegal activity. HOUSTON BOTANIC GARDEN

If you are looking for inspiration for our now sad-looking gardens, you might want to consider a Springtime visit to the Houston Botanic Garden. Located at One Botanic Lane, a short 20-minute drive from Marilyn Estates along S. Loop 610 to exit 39, on I-45 S. (at the Hobby Airport exit). The Gardens are located on 132 acres along Sims Bayou and was opened to the public in September 2020. There are 2.5 miles of walking trails with easy access for those with limited mobility.

The Botanic Garden is a living museum for plants that is divided into sections; culinary, global, pine grove, coastal prairie, and stormwater wetlands. There are a variety of permanent sculptures scattered throughout the grounds as well as travelling exhibitions – currently *Glass in Flight* (thru Jan. 31st) and a holiday evening light show that has a different theme each year.

There is a lovely shop that has a variety of garden-related items and a covered area with tables and chairs, so bring along a picnic. Better yet, make a day of it and stop at the Houston Audubon Society, a living habitat for various raptors, and Glenbrook Park. All are located along the Bayou. Admission prices are: Adults- \$15, Children 3-15- \$10, Students- \$10.

Harris County progress on construction of Meyergrove detention basins

The overview

Work is moving forward on a Harris County Flood Control District project meant to reduce flooding in the lower portions of the Brays Bayou watershed.

The first of the two planned basins is located on a 7.5-acre site just inside Loop 610 between the bayou and North Braeswood Boulevard, at a site formerly occupied by Meyergrove Apartments, according to HCFCD officials. The second basin will be located on a smaller site in the median between North and South Braeswood Boulevard, and between the railroad crossing and Linkwood Drive.

The backstory

The project has been funded by just under \$10 million in federal funds. The project will also be funded in part by the HCFCD's 2018 bond program.

The larger, 7.7-acre basin will support overflow from Brays Bayou with a concrete weir, which will be constructed between the basin and Brays.

The project will also include a small lake with wetland plantings, creating a parklike setting, as well as new trail construction in the area. Part of the existing 4-foot -wide sidewalk along Braeswood will be expanded to a 10-foot-wide hike and bike trail.

The smaller, 3-acre basin will be a dry-bottom basin with a grassy bottom and will be designed to drain between rain events. It will hold 10 acre-feet of water. The two basins combined will have the capacity to store roughly 30.6 million gallons of stormwater.
