# **Security Report**

Please continue to be aware of our neighborhood activity and report any suspicious people and vehicles in our area by calling Constable Precinct 5 dispatch at (281) 463-6666 and providing the location and description and license plate number if you can see and write it down. Law enforcement highly recommends every homeowner to install cameras to record activity to be used as evidence and lead to arrest and conviction, along with installing home alarm systems.

You are also encouraged to utilize vacation watch on your home while away. There is a link on the Marilyn Estates Association website to access the online form. Here is the process and more security tips from Precinct 5: Residents who live within a Precinct 5 Contracted Patrol Area may submit a Vacation Watch Request whenever they will be away from their home for more than a day. A Vacation Watch lets the deputies who patrol your area know to keep an extra eye on things while you are away.

The quickest way to submit the request is to fill out the online form. If you prefer, you may contact our dispatch office and have a deputy come to your residence to record the request.

**ALARMS:** Precinct 5 recommends that you notify your alarm company to make our agency the first contact point when your alarm is triggered, even above yourself. This will save valuable time and get law enforcement enroute immediately should your alarm go off.

**LIGHTS:** If you are going to leave lights on, consider placing them on timers, or ask a neighbor to turn them on and off for you. Exterior lights should only be left on if they are equipped with dusk to dawn sensors. Lights left on overnight are ok, but exterior lights left on through the day can be a sign that no one is home.

**VEHICLES:** No matter where you leave your vehicle, do not leave valuables inside. If there will be no vehicles parked in front of your house or in the driveway, ask a neighbor if they would park their car in your driveway.

**PETS:** Having a friend watch your pet while you're gone is a great idea, but make sure your dog or cat has updated ID tags with good contact information for you on them. That way, in the event your pet gets out, they can be traced back to you.

**VISITORS:** The best way to avoid having your house look empty is to not have an empty house. Finding a friend to "house sit" for you is not only a smart idea, but it takes care of other issues as well, like a pet sitter, parking a car in the driveway, etc.

# **Architectural Control Committee**

Committee Position - New Member Needed – If you are interested in becoming a member of the ACC Committee, please contact Ed Fastow. You can be part of a group that helps keep our neighborhood looking great.

As a Deed Restricted Community, we want to remind our neighbors that Architectural Control Committee (ACC) approval is required for ALL modifications of existing structures and the construction of a new structure on your property lot. Essentially, approval is required for anything that changes the outside appearance of your property structures. Examples include house colors for painting (including doors, shutters) and repainting- although the color may be the same; all visible fences, temporary structures, driveways, sidewalks, roofs/ replacements, pools/spas. With regards to pools and spas, the ACC reviews property lines, easements and building lines. The ACC also reviews the placement of solar panels, as well as window and door replacements.

Remember, should a variance is required for your project, the ACC cannot grant the variance. Only the Board of Directors is permitted to do so. Please submit your project well in advance of the start date to avoid any delay.

# Roof Replacements and repairs, Painting projects (same or changed color) and Fences were the most common of the fourteen approvals requested this quarter.

# **Deed Restrictions**

Your Deed Restriction Enforcement Committee continues to monitor and address issues with Block Directors and homeowners in an effort to preserve our deed restrictions and protect property values.

When we are able to communicate directly with the owner, enabling a mutual understanding of any extenuating circumstances, we can almost always agree on a reasonable resolution acceptable to all. This avoids the necessity to escalate to a legal notice, board action, imposition of fines and legal fees.

Again, this quarter, we are happy to report <u>significantly fewer violations</u> were addressed with a total of 17 issues, the lowest number in three years. Much thanks to our neighbors for their understanding and cooperation.

#### Please submit Vacation Watch Requests at least 3 days prior to your departure date to ensure deputies receive them in time. If you're within three days, you may still submit on-line, but also call the dispatch line at (281) 463-6666 so that your request can be expedited.

### New Trails along Brays Bayou by Nancy Hixon

On January 28<sup>th</sup> there was a kickoff and celebration for the start of construction for a host of new projects in our area. Among the projects will be the Captain Herod Memorial Plaza located on N. Braeswood and the pedestrian bridge at Atwell. In conjunction with the Plaza, a new 10-foot-wide trail along the streetside of N. Braeswood between Chimney Rock & Hillcroft is now under construction.

Capt. Herod was a Texas National Guard pilot who sacrificed his life in 1961 by guiding his jet plane away from thousands of nearby homes and crashing into an open area along Brays Bayou. HISD Herod Elementary is named in his honor. Brays Bayou Association and President Charles Goforth initiated this project and helped raise the necessary community donations.

In addition, there will be four new underpasses and lower-shelf trails along Brays Bayou at S. Rice, Chimney Rock, Hillcroft and N/S Braeswood. Eventually there will be three new underpasses at Fondren, Braes Bayou Drive, and Bissonnet Street plus the replacement of an existing 8' wide asphalt trail with a 10' wide concrete trail between Fondren and Braeburn Glen. Going East, construction is underway to construct a lower shelf trail between Stella Link and Buffalo Speedway.

You may have also noticed that the Meyergrove Detention Basin at Loop 610 and S. Braeswood is now complete with a 10-foot-wide trail/sidewalk around its perimeter. This basin will help with the prevention of flooding in our area.
